- 1. Terry Walker opened the meeting, welcoming those present.
- 2. The agenda was approved.
- 3. The minutes of the previous meeting on 26th August 2020 were approved.
- 4. President Terry Walker reported on her activities and news since the last meeting; the pandemic has altered the work of the president. - 9. We discussed the 'BA Thesis Awards'. We agreed to prize money to increase the prize to 2000 SEK and to discuss and review guidelines for awarding the prize with each of the committees of judges.
- 10. At present no venue for the National Forum 2023 has been agreed. We will invite offers from the membership at the general meeting. We discussed SWESSE might sponsor a lecture by a representative of ESSE at the National Forum, perhaps entitled 'The Biannual SWESSE Lecture 20XX'. The speaker would be agreed between the SWESSE board and the organising committee of the forum.
